



PROPERTY FACT SHEET

Live! Casino & Hotel Philadelphia is a **\$700 million world-class gaming, hotel, dining and entertainment destination** being developed by Stadium Casino LLC, an affiliate of The Cordish Companies. Located in the heart of the South Philadelphia Stadium District, Live! Casino & Hotel will set a new standard for development in the City in the areas of economic opportunity and inclusivity for local residents. The project will generate over \$2 billion in economic stimulus to the City, along with \$100 million in tax revenues for the City in its first five years of operation, including \$25 million to Philadelphia's School District. Stadium Casino LLC has committed to a groundbreaking Community Benefits Plan with the City of Philadelphia that includes unprecedented goals in minority and local construction and hiring initiatives, a commitment to living wages for all 5,000 employees, more than \$15 million in grants in the first 10 years to support improvements and enhancements to the local community, and the creation of a Community Advisory Committee.

The new Live! Casino & Hotel spearheads the transformation of the Philadelphia Stadium District into an integrated sports, entertainment and casino resort destination. The project sits adjacent to Xfinity Live!, the highly successful dining, entertainment and hospitality destination developed and owned in partnership between The Cordish Companies and Comcast Spectacor. Since opening in 2012, Xfinity Live! has welcomed millions of guests, energizing the Sports Complex year-round and dramatically enhancing the fan experience for local and visiting sports fans. The opening of the \$700 million casino resort destination will transform the Philadelphia Stadium District into the only place in the country to experience big league action from four major professional sports teams, best-in-class dining and entertainment, and world-class gaming and hotel accommodations.
